## **OLD BUSINESS:**

Approved Minutes from June 11<sup>th</sup> & July 30<sup>th</sup> meeting. Marc 1<sup>st,</sup> Gary 2<sup>nd</sup>

- Status of Freightliner electrical work (lights & siren). Jon Cunningham will resume work on truck when we can get it scheduled. Stickers for the truck were reviewed and approved at Signs Now.
- 2003 Ford F350 was sold for \$9,550 \$750 5% commission to State Surplus.
- DNRC 1999 Dodge is covered by the State and VFIS for Liability only and not eligible for towing expenses. Would need to add Comprehensive coverage.

- Update on MPERA/VFCA missing training certifications from 2018-2020. Hours have been corrected by the new MPERA Director and he acknowledged there was a recording problem within the department that was being investigated. Members will need to check annual statements in late December/early January to verify corrections.
- U.S. Bank account signers updated. Authorized Signers are Ann Baker, Jon Maxwell, Marc Bridges. This is now a one signature only account as the county cannot monitor 2 signatures.

## **NEW BUSINEES:**

- Reviewed Credit Card charges new Credit Card for David Knoepke to be applied for as L&C County is discontinuing our current credit card. Dave to look into replacing county credit card with U.S. Bank credit card.
- A 2nd yard light on the pole at back of station would run \$6.91 per month. Jon will proceed with the agreement and installation with Northwestern Energy.
- Snow Removal: Quote for \$650 from Brian McDaniel for 2024-2025 approved.
- Trustee Terms: Gary Baker's term expires in 2025. He agreed to another term of 3 years.
- Mail in Ballots were approved for the Election process should there be more than one candidate running for election. We can use 10/16/24 as the effective date going forward on the Counties notification letter each year.
- Recruitment Procedures: Fire Chief will determine those fire fighters that are accepted. Canyon Creek VFD might have members that may be interested in joining Marysville VFD. Dave will do a background check and email the Trustees of newly accepted fire fighters.
